SUMMARY:

The California Office of Emergency Services (Cal OES) requires that non-State agencies have a current (within the last three years) Resolution on file in order to obtain financial assistance under P.L. 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act. It is necessary to designate employees occupying certain positions within the City as authorized signers on applications and documents necessary to obtain financial assistance in the event of a qualifying emergency;

On July 4, 2019, and July 5, 2019, Governor’s Proclamations were issued to secure funding to help local jurisdictions respond and recover from the California Earthquakes. The incident period is July 4, 2019, and continuing. The California Earthquakes incident (CDAA-2019-05) makes available CDAA funding for eligible costs in Kern and San Bernardino Counties.

CDAA application packets must contain the following:

- Project Application California Disaster Assistance Act Program (Cal OES 126)
- List of Projects (Cal OES 95)
- Designation of Applicant’s Agent Resolution (Cal OES 130)

This resolution and signing authority is needed to help expedite certain reimbursement costs incurred by the City.
